**A RESOLUTION ADOPTING THE ANNUAL UPDATE TO THE CAPITAL
IMPROVEMENT ELEMENT OF THE BRYAN COUNTY 2018
COMPREHENSIVE PLAN UPDATE**

WHEREAS, the Bryan County Board of Commissioners adopted the Capital Improvement Element (“CIE”) to the Bryan County Comprehensive Plan on January 8, 2019; and

WHEREAS, the Bryan County Board of Commissioners adopted the First Amendment to the Capital Improvement Element on May 9, 2019;

WHEREAS, the Bryan County Board of Commissioners adopted the Second Amendment to the Capital Improvement Element on October 13, 2020; and

WHEREAS, Bryan County has prepared the State required annual update to the CIE to maintain its qualified local government status; and

WHEREAS, Bryan County held an advertised public hearing on July 13, 2021, the purpose of which was to present and receive comments on the annual update to the CIE; and

WHEREAS, the Coastal Regional Commission and Georgia Department of Community Affairs have reviewed the annual update to the CIE and determined the annual update adequately addresses all statutory requirements.

NOW THEREFORE, BE IT RESOLVED, that the Bryan County Board of Commissioners hereby approves this resolution adopting the annual update to the Capital Improvement Element to the 2018 Bryan County Comprehensive Plan.
